## NEW FIREARMS PURCHASE PERMIT PROCEDURES

All Nebraskans have an important role to play in stopping the spread of COVID-19 and saving lives. To ensure the welfare of the public and our employees, we are no longer accepting firearm purchase certificate applications in-person at our public counter. All applications will now be handled via U.S. mail. Instructions for submitting an application are as follows:

- 1. You must be 21 year of age or older to submit an application
- 2. Carefully read and complete the application. If there are any questions that do not apply to you please place a N/A in the box.
- 3. You must have your signature notarized on the second page of the application
- 4. Include a phone number at the top of the application
- 5. Mail the completed application with a photocopy of your Nebraska Driver's license/state ID with your current address and enclose \$5.00 fee payable to:
