## Job Summary:

Performs semi-skilled line work in the operation, construction, maintenance, and repair of overhead and underground electric distribution and transmission systems under the direct supervision of a Journeyman Lineman, Electric Department Foreman, or Electric Department Superintendent.

# **Essential Functions:**

Under the direct supervision of a Journeyman Lineman, Electric Department Foreman, or Electric Department Superintendent an Apprentice Lineman's essential functions include:

- Hands-on completion of new construction and rebuild projects (overhead and/or underground), completing all steps necessary to complete assignment. Follow safety and proper procedures in all phases of the project. Assist in providing proper documentation at completion of project for recordkeeping.
- Hands-on completion of maintenance activity (overhead and/or underground) for the electric system. React to needs that are identified during other work on the system, as well as follow prescribed preventative maintenance tasks. Follow safety and proper procedures for all activities. Assist in providing proper documentation at completion of task for recordkeeping.
- 3. Complete tree trimming as needed.
- Complete miscellaneous work as needed by the Department or other City Departments.
  Including items such as, vehicle and equipment maintenance, departmental assistance, replacing lighting at recreational complex, etc.

- 5. Complete on-call duty as required. Complete all on-call assignments during on-call period including emergency outages and repairs, out-of-service conditions, and substation monitoring.
- 6. Perform routine maintenance and repair of plant equipment and distribution, production, and collection system.
- 7. Perform, install, and maintain locates, service connects and disconnects, traffic signals and street lights, meter install and changes, and security lights.
- 8. Perform construction, installation, maintenance, and repair of electrical distribution and transmission lines. Set pols, string wire, and hang or install transformers, lightning arrestors, cutouts, cross arms, and insulators. Install and connect meter reading equipment, switches, lightning arrestors, and related components.
- 9. Drive and operate a line truck with various types of equipment attachments, such as hydraulic derrick and pole hole auger.
- 10. Operate medium to heavy equipment in the general maintenance of electric system. This equipment may include Bucket Truck, Skid Loader, Dump Truck, Trencher, Wire Puller, and Wood Chipper, as well as other related equipment.
- 11. Subject to emergency response in the event of utility outages or emergencies.
  - The following essential functions are not required to be performed under the direct supervision of a Journeyman Lineman, Electric Department Foreman, or Electric Department Superintendent.
- 12. Work with other City Departments for snow removal and general clean up after storms or other emergencies.
- 13. Ability to perform CPR and administer first aid including pole top rescue techniques.
- 14. May be called to respond to alarms while off duty or be required to stay past shift to complete a call of service.
- 15. Comply with all of the Department's safety policies and rules. Must report safety violations and potential safety violations to their supervisor.
- 16. Travel and tour City projects in adverse conditions, to include but not limited to, accident sites, construction sites, outdoor sites, remote sites, interior and exterior building inspections, etc.
- 17. Perform services when exposed to extreme temperatures and adverse weather conditions; hazards associated with traffic control and working in and near traffic; natural and manmade disasters; and hazardous materials incidents; and when one hundred plus feet (100+') above grade.

- 18. Keep confidential information confidential and be HIPPA compliant.
- 19. Work the days and hours necessary to perform all assigned responsibilities and tasks. Must be available to communicate with subordinates, supervisors, customers, vendors and any other persons or organizations with whom interaction is required to accomplish work and employer goals.
- 20. Punctual and timely in meeting all requirements of performance, including, but not limited to, attendance standards and work deadlines; beginning and ending assignments on time; and scheduled work breaks, where applicable.
- 21. Perform other work which is consistent with the essential functions of the job.
- 22. Perform other duties as assigned.

Must possess a valid driver's license and maintain an insurable driving record.

Must obtain a CDL endorsement within ninety (90) days from date of hire.

Must have completed an accredited entrance level line works course.

- 2. Ability to perform pole top rescue annually.
- 3. Ability to crawl, run, climb, bend, stoop, twist, reach, contort and lift up to 100 lbs.
- 4. Ability to sit or stand for long periods of time, but also have the mobility to respond immediately for emergency incidents.
- 5. Hand, eye, and body coordination to operate light to moderately heavy machinery, equipment and vehicles.
- 6. Ability to withstand extreme weather conditions.
- 7. Exposure to vibrations.
- 8. Ability to transverse rough terrain on foot.
- 9. Ability to work with exposure to noise.
- 10. Ability to distinguish among colors.
- 11. Ability to drive city vehicle.
