# **ORDINANCE NUMBER 23-22**

An ordinance to repeal Sections 24-47 through 24-70, inclusive, of the Beatrice City Code regarding occupation taxes; to repeal all other conflicting ordinances or parts of ordinances; and to provide for publication in pamphlet form and for an effective date of this ordinance.

**SECTION 1.** That Sections 24-47 through 24-70, inclusive, of the Beatrice City Code be and hereby are repealed.

**SECTION 2.** That all ordinances and parts of ordinances in conflict herewith are hereby repealed.

**SECTION 3.** This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.

# **DIVISION 2. TAX SCHEDULE**

#### Sec. 24-46. Generally.

An occupation tax is hereby levied in the amounts specified on the various businesses and occupations listed in this division and conducted or pursued within the city. For the purposes of this division, the catchlines of the sections set out herein shall be deemed substantive parts of the sections.

SUBJECT: Repeal of Sections 24-47 to 24-70 EXHIBIT(S): Ordinance #23-\_\_\_

Since at least 1971 the City has had a variety of occupation taxes which included auctioneers, bowling alleys, animal exhibits, and merry-go-rounds. In FY22 these miscellaneous occupation taxes brought \$1,235 to the City. The Code Committee recommends the repeal of Sections 24-47 to 24-70 regarding a variety of

Section 24-71 regarding tobacco occupation tax remains due to Regulation 57-002 requiring a person seeking a state permit to show proof that they have obtained a city permit.
