WHEREAS, the Mayor and City Council of Beatrice, Nebraska, have reviewed said request and desire to grant Main Street Beatrice, and their designees, permission to serve alcoholic beverages and to sell or offer for sale or peddle goods, wares, or merchandise upon the City Property located in the City Auditorium on Saturday, June 1, 2024, from 2:00 p.m. to 8:00 p.m., as part of their Taste of Spring fundraiser.


