#### Board of Health

The Board of Public Works (BPW) consists of five members, who are appointed by the Mayor and approved by the City Council. The members serve staggered terms of five years and must be a resident of the city.

The Citizens Advisory Review Committee (CARC) is composed of five members who are resident taxpayers of the city. The members are appointed by the Mayor, with the approval of the City Council. At least one member of the CARC must have expertise or experience in the field of business finance...
