WHEREAS, beverages are sold at the concession stands on property owned by the City of Beatrice ("City"), specifically at Hannibal Park and at the Big Blue Waterpark; and

WHEREAS, the City desires to enter into an Exclusive License Agreement with LinPepCo Partnership d/b/a Pepsi-Cola Lincoln wherein the City shall receive a license fee and a rebate per case sold at these locations in exchange for exclusively selling Pepsi products at these locations.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BEATRICE, NEBRASKA:

SECTION 1. That the Mayor and City Clerk are hereby authorized to execute the Exclusive License Agreement between the City of Beatrice, Nebraska and LinPepCo Partnership d/b/a Pepsi-Cola Lincoln, wherein the City agrees to exclusively sell Pepsi products at these locations in exchange for receipt of a license fee and a rebate per case sold. A copy of said Exclusive License Agreement, marked as Exhibit "A", is attached hereto and incorporated by reference.

SECTION 2. That all resolutions or parts of resolutions in conflict herewith are hereby repealed.

Exhibit "A"

EXCLUSIVE LICENSE AGREEMENT

LinPepCo Partnership d/b/a Pepsi-Cola of Lincoln ("**Supplier**") and City of Beatrice ("**Customer**") headquartered in Beatrice, NE, hereby agree as follows:

- 1. <u>Venue</u>. Customer owns Hannibal Park and the Beatrice Water Park, both located in the City of Beatrice, Nebraska.
- <u>Term</u>. The term of this Agreement will be for a period of five (5) years beginning on March 1, 2024, and will continue through February 28, 2029 (the "Term").
- 3. <u>Scope</u>. During the Term, Customer shall purchase from Supplier (i) Pepsi-Cola's and Dr Pepper's corporate branded postmix products, as listed in Exhibit A, for use in preparing fountain beverage products sold under the trademarks of Pepsi-Cola and Dr Pepper (the "Fountain Products"); and (ii) Pepsi-Cola's corporate branded packaged beverage products (including carbonated soft drinks, waters, isotonics, juices, juice drinks and/or coffee based beverages), as listed in Exhibit B (the "Packaged Products"), (collectively the "Beverage Products") to be sold in each of the Customer's existing, as noted in Exhibit C, and after-acquired venues (collectively the "Venues"). Supplier reserves the right to amend from time to time the Beverage Products listed on Exhibits A and B.
- 4. <u>Exclusive License</u>. Customer hereby grants to Supplier an exclusive license with respect to the Beverage Products at Venues as follows: the Beverage Products distributed by Supplier shall be the exclusive products of their respective types sold, dispensed or otherwise made available in any manner or form, including vending machines, coolers, and fountain, or in any way displayed, represented or promoted at or in connection with Customer and/or Venues (the "Exclusive License").
- 5. <u>Equipment</u>. Equipment relating to the Beverage Products shall be provided, maintained, and repaired at Supplier's expense. At all times, legal title to the Equipment shall belong to Supplier.
- 6. <u>Advertising</u>. The Exclusive License shall include the right of Supplier to be the sole advertiser of Beverage Products at Venues.
- License Fee. In consideration of the Exclusive License, Supplier shall pay Customer on or before April 1, beginning April 2025, of each year (i) the sum of one thousand dollars (\$1,000); and (ii) the sum of \$7.00 multiplied by the number of cases (24 pack) of Packaged Products sold during the preceding year (collectively the "License Fee").

- 8. Pricing. A current delineation of the prices charged for the Beverage Products is set forth on Exhibits A and B attached hereto. Any changes to the pricing of the Beverage Products shall be mutually determined by both parties; provided, Supplier reserves the right to increase prices due to any increase in the prices it pays for Beverage Products. The prices in Exhibits A and B do not reflect applicable deposit laws or beverage fees and taxes imposed on the sale of Beverage Products ("Beverage Taxes"). Supplier shall collect Beverage Taxes as required from the parties that purchased the Beverage Products.
- 9. Breach & Cure. Failure of either party to this Agreement to abide by any provision set forth herein shall constitute a breach of this Agreement. In such event, the non-breaching party may provide written notice to the breaching party describing the breach. The breaching party shall rectify, cure, or refute the alleged breach within thirty (30) calendar days. If the breaching party fails to rectify, cure, or refute with thirty (30) calendar days after receiving notice of said breach, the non-breaching party may terminate this agreement without notice.
- 10. Termination. This Agreement may be terminated by either party if the other party shall be in breach or default under any one or more of its covenants or agreements contained herein and such breach or default is not cured within thirty (30) days after written notice to the defaulting party.
- 11. <u>Remedies</u>. In the event of a default by a party, the non-defaulting party may exercise any and all rights and remedies allowed by law and/or equity.
- 12. Binding Effect. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their successors and assigns.
